

INFORMATION ON PERSONAL DATA PROCESSING

BASIC SUMMARY

Kiteseason s.r.o., Company ID No.: 01397982, with its registered office at Mlýnská 326/13, 602 00 Brno, processes your personal data as it is necessary for the performance of a contract with you related to the booking of tours and other travel services (or for taking steps prior to entering into such a contract), and also for fulfilling the company's legal obligations.

1. IDENTITY AND CONTACT DETAILS OF THE CONTROLLER

1.1. The controller of your personal data is Kiteseason s.r.o., with its registered office at Mlýnská 326/13, 602 00 Brno, Company ID No.: 01397982, registered in the Commercial Register maintained by the Regional Court in Brno, Section C, Insert 77903 (hereinafter referred to as the "Controller").

1.3. The Controller has not appointed a Data Protection Officer.

2. LEGAL BASIS FOR PERSONAL DATA PROCESSING

2.1. The legal basis for processing your personal data is the necessity of such processing for:

2.1.1. the performance of a contract between you and the Controller or for taking steps by the Controller prior to entering into such a contract within the meaning of Article 6(1)(b) GDPR;

2.1.2. compliance with legal obligations within the meaning of Article 6(1)(c) GDPR, especially pursuant to Acts No. 235/2004 Coll. (on VAT), No. 586/1992 Coll. (on income tax), and No. 563/1991 Coll. (on accounting).

3. PURPOSE OF PERSONAL DATA PROCESSING

3.1. The purpose of processing is to perform the contract, including the arrangement of the tour, invoicing, handling warranty claims, taking pre-contractual steps, and complying with legal obligations.

3.2. No automated decision-making within the meaning of Article 22 GDPR takes place.

4. PERSONAL DATA RETENTION PERIOD

4.1. Personal data will be processed for the duration of the contractual relationship and subsequently for the period required by applicable legal regulations (e.g. accounting legislation).

5. RECIPIENTS OF PERSONAL DATA

5.1. Recipients may include shipping services, IT administrators and providers, accountants, legal and tax advisors.

5.2. Personal data may also be disclosed to public authorities under applicable legislation (e.g. the tax authorities).

5.3. The Controller does not intend to transfer personal data outside the EU or to international organizations.

6. DATA SUBJECT RIGHTS

6.1. You have the right to access, rectify, erase, restrict processing, data portability, and the right to object.

6.2. You have the right to lodge a complaint with the Office for Personal Data Protection (www.uoou.cz).

6.3. The provision of personal data is necessary for the conclusion of the contract; without it, the contract cannot be concluded or fulfilled.
